#### 1. Introduction

In February 2021, the Department of Education commissioned CCEA to look at how best to adapt its qualifications in 2021/22 to take account of the disruption to teaching and learning caused by the COVID-19 pandemic. CCEA's advice was subsequently shared with the Department of Education for consideration.

On 17 May 2021 the Education Minister, Peter Weir MLA, announced a return to public examinations during the next academic year, along with significant reductions in the assessment requirements across a range of CCEA qualifications.

This document sets out the changes to CCEA qualifications for 2021/22 emanating from the Department of Education's decisions.

These changes apply only to candidates who are cashing in at qualification level in Summer 2022.

The changes may be summarised as follows:

- In the majority of GCSE and GCE qualifications, CCEA has defined one unit of assessment which may be omitted for candidates completing the qualification in Summer 2022.
- This unit omission is optional, and the unit will still be available for any candidates wishing to be assessed in all units.
- Should candidates choose to sit all units of the GCSE or GCE, they will receive the higher grade from their performance in all units or in the mandatory units only.
- Where possible, internally assessed tasks issued in the academic year 2019/20, and carried across into 2020/21, will be carried over for a further academic year for submission in Summer 2022. This will be detailed in the 2021/22 specification addendum for each relevant qualification.
- Visiting Examination and Visiting Moderation will be in place for Summer 2022; however,
   CCEA will keep this under review in light of the changing public health context.
- In Occupational Studies, candidates can omit one unit of their choice from final assessment. Should candidates choose to sit all units, they will receive the higher grade from their performance in all units or in the mandatory units only.
- In Entry Level and Vocational Qualifications, candidates can omit assessments up to a maximum of 50% of the qualification.

In all cases centres should aim to cover the full specification.

### 4. Occupational Studies Omissions

Centres may select one unit of their choice for omission from the chosen occupational area. This means only one unit is required to be assessed and submitted to CCEA for moderation in 2022.

Candidates may complete assessments in both units if they so wish. Should candidates choose to sit both units, they will receive the higher grade from one or both units.

Centres should still aim to deliver, as far as possible, the full specification content for two units.

#### 5. Entry Level and Vocationally Related Omissions

Centres may select units of their choice for omission worth up to a maximum of 50%, i.e. units worth up to 50% of the guided learning hours assigned to the qualification.

For example, for a qualification with 120 guided learning hours, only units totalling 60 guided learning hours are required to be assessed and submitted to CCEA for moderation in 2022.

Centres should still aim to deliver, as far as possible, the full specification content for all units.
